EuroCham's Broader Role in Private-Public Sector Dialogue

- Public-private dialogue as the first step to identify bottlenecks for private sector investments
- More dialogue may enable RGC to more efficiently allocate A4T and/or "I4T"
- The private sector could be involved at different levels of RGC's trade development policies
- Sectorial Committees could become means for the development of more public-private partnerships to enhance trade sector development
