**to assist DICO carry out finance related transactions under the framework of TDSP**

1. The Royal Government of Cambodia (RGC) through the Ministry of Commerce (MOC) has received financing in the amount of approximately US\$ 12.35 million equivalent, from the Multi Donor Trust Fund, contributed by the European Commission, DANIDA and UNIDO. The fund will be managed by the World Bank as “trustee” to support the “*Trade Development Support Program (TDSP)*” with the Department of International Cooperation (D/ICO) of Ministry of Commerce as implementing agency responsible for managing the overall implementation and coordination with other line ministries and stakeholders. The Ministry intends to apply part of the proceeds to payments for goods, works, and consulting services to be procured under this project. The D/ICO, serving as Project Coordination Unit, is recruiting a **project national financial advisor** to carry out and assist the D/ICO serving as Project Coordination Unit on all finance related activities in compliance with the World Bank guidelines. The services to be provided include but not limited to, build up capacity of the D/ICO financial management team, produce the supplement Financial Management Manual for the specific needs of the project implementation, provide oversight, monitoring and supervision of the D/ICO financial management team...etc (more roles and responsibilities are described in the TOR).

The TDSP has four components, with component 1: Trade Policy Formulation and Implementation, supporting trade policy formulation and implementation, Component 2: Performance Monitoring, supporting activities to develop a transparent, consistent, and sustainable performance monitoring system, Component 3: Strengthening Institutional and Human Capacity and Component 4: TDSP and Trade SWAp Management,
3. Acting on behalf of the Cambodia Trade Development Support Program (TDSP), Department of International Cooperation (D/ICO) invites expressions of interest from qualified and experienced individual consultants to undertake the above mentioned services which are further detailed in the Terms of Reference for this assignment. The successful consultant will be selected in accordance with the procedure set out in Section V, Selection of Individual Consultants under the World Bank’s Guidelines: Selection and Employment of Consultants by World Bank Borrowers, May 2004 and revised October 2006.

In submitting their expressions of interest, interested consultants must provide their updated curriculum vitae, indicating personal and technical skills, academic qualifications, experience in similar assignments, experience in Cambodia and/or other developing countries along with the names of at least three (3) referees with contact information (e-mail address, telephone or fax numbers).
